SENEDD VISIT TO MARK 75th ANNIVERSARY OF NATIONAL PARKS AND ACCESS TO THE COUNTRYSIDE ACT IN WALES

On 5th March our Chairman Martin together with Executive members Sue Hoddell and Katherine Jordan visited the Welsh Parliament to take part in an event organised by the Campaign for National Parks to celebrate 75 years of the National Parks and Access to the Countryside Act in Wales.

The event was sponsored by Carolyn Thomas MS for North Wales and speeches were given by Julie James MS, Minister for Climate Change and Llyr Gruffydd MS for North Wales. A lively speech from Alun Elidyr on the challenges of farming in Eryri entertained the audience of around 100 people. We also enjoyed a presentation by Dianne Spencer and Louise

Southwell on regenerative small-scale agriculture in Bannau Brycheiniog and the Our Food 1200 project as well as Primrose Market Garden Felindre.

The day provided a good opportunity to network with other Friends groups from around Wales as well as CNP staff and many others involved in our National Parks.

The encouraging speeches from the Senedd members will hopefully lead to another 75 years of our Welsh Designated Landscapes thriving for nature, our communities and the planet.

PUBLIC RIGHTS OF WAY BLOCKED IN 32,000 PLACES.

In January, the BBC reported walkers wanting to enjoy footpaths across the British countryside are being blocked or obstructed in nearly 32,000 places across England and Wales. It's a reminder to us to protect our access to Rights of Way. Use them or lose them. In my view, Bannau Brycheiniog

National Park performs an excellent job, with resources provided, to address Rights of Way issues. All members can help and play a part in ensuring problems they encounter are brought to the attention of the National Park by reporting the issue on our website. It's a simple procedure. If you have any questions, I'm happy to hear from you.

Sometimes it becomes necessary to visit a location to inspect a ROW matter and I'm indebted to Angela Morgan (west), Helen Fletcher (central) and Frank Scott (east) who have kindly volunteered to assist should an onsite visit be needed.

PENMARCH AND MERTHYR COMMON WIND FARM APPLICATIONS

We are closely monitoring proposals to develop several wind farms on the edge of the Brecon Beacons. One of these would be very close to the national park boundary on Penmarch and Merthyr Common to the north of the A465. Due to their scale, the proposals will be dealt with as Developments of National Significance and will be determined after a public hearing has been held. Having lodged an initial objection, the Society has been invited to attend at a date to be confirmed.

As a result of these proposals, the Society is in the process of developing a Renewable Energy Policy and has established a working group with a first draft of a policy nearing completion. The overarching policy once finalised should assist with the consideration of future renewable energy projects close to the national park boundary. If any members have a special interest in this issue or special skills or knowledge in the renewable energy field and would like to help finalise the policy please do get in touch.

we are keen to take on more volunteers, particularly members who have knowledge and experience in industrial archaeology. For more information please contact Roy Manning via:-



Give every child a school visit to a National Park, campaigners urge

First Minister hopefuls. (Press release by Campaign for National Parks Feb 2024)

To celebrate the 75th anniversary of the founding of National Parks, Campaign for National Parks and the Alliance for Welsh Designated Landscapes are urging candidates Jeremy Miles and Vaughan Gething to safeguard the future of National Parks and Landscapes in Wales, if successfully elected as First Minister.

To help with these efforts, Campaign for National Parks and the Alliance have published a ten-point action plan to securing the long-term health of the parks and are calling on the next First Minister to implement them fully, for the benefit of people, society and the planet. The programme includes every child to visit a National Park as part of the national curriculum, greater regulation of Airbnb and holiday lets, and tighter nutrient management regulations to crack down on water pollution.

Commenting, Gareth Ludkin, Senior Policy Officer for Campaign for National Parks said:

"The three National Parks in Wales cover 20% of the country's land surface and are home to over 80,000 people, yet it's unclear where either First Minister candidate stands on the importance of our National Parks and Landscapes and what action they will take to give them a brighter future."

"Too often we hear of children and young people who have limited or no access to our most treasured Welsh landscapes. Providing an outdoor learning experience for every child in Wales as part of the National Curriculum would help establish a deeper understanding of rural life in Wales as well as a lifelong love, respect and appreciation of the natural world, and all of the benefits they bring to our health and wellbeing."

"In the face of climate breakdown, a nature crisis, growing inequality and a hollowing out of rural communities, Designated Landscapes can play a vital role in tackling some of Wales' biggest challenges, if properly embraced by the next First Minister and their Government. "

"With another National Park being considered in Northeast Wales there are exciting opportunities for the successful candidate to set out a truly dynamic

and progressive agenda for our National Parks that provides for Wales's communities, environment and health. This includes delivering on nature recovery commitments made by the Welsh Government, as outlined in the 2018 Valued and Resilient report and 2022 Biodiversity Deep Dive."
